

Completing the Anacostia River Trail Network



- The Anacostia Waterfront
 Framework Plan set the vision in 2003 for the Anacostia River
 Trail.
- The plan charged the District to complete 20 miles of continuous trail from the Washington Channel to the Maryland border, on both sides of the Anacostia River.
- The purpose of this project is to provide a pedestrian/bicyclist connection through the Buzzard Point neighborhood from the FDMB bridge to 2nd Street SW.













Half Street bike lane should continue north to Connect Half St is notorious for rogue street/Buzz Pt Park land parking and high speeds, so parking enforcement will be key for safety of mixing peds/bikes/cars

Would love access through the Fort if ever possible

Half Street should continue north to Connect

Half street bike lane should continue north

Protected is critical (not just flexiposts) Adjacent construction impacts should be considered (debris causes issues in many cases) Speed needs to be addressed, LOTS of speeding currently on Half Stre

Do you have comments on the suggested route shown?

Install protected bike infrastructure on Half Street ASAP so less of a battle once Buzzard Point is built out

Speed + illegal parking/idling of construction vehicles on Half Street is current issue that can/should be addressed through this project



Are there any streets we should avoid?

There should be bike lanes on every street

Audi Drive / Private section of 1st St -- section completely closes frequently for DC United games and other large Audi Field events and service, food truck, and other vehicles park there instead

Too much parking in the area

With capitol street should have better bike lanes

possible
