For more than 10 years, the Choose Clean Water Coalition has brought together nonprofits, funders, elected officials, state and federal agencies, and other stakeholders around our common goal—clean water. And while we have found success in our joint efforts much work remains and some of our toughest challenges still lie ahead.

Climate change is impacting not only our water quality, but the lives of the millions of people who live in the Chesapeake watershed. Our Focus

Grow and mobilize a more inclusive movement of clean water champions

The Coalition convenes and connects clean water advocates in NY, PA, DE, MD, VA, WV, and DC. Our more than 270 member organizations strive to authentically reflect and amplify the voices of the diverse communities they represent through our leadership, programs, and shared commitment to build a more inclusive network of champions.

Expand the capacity of Coalition members to be strong advocates for clean water and resilient communities

The heart of our Coalition is our membership. Each member organization is unique and plays a critical role in supporting local communities to protect their rights to clean water. The Coalition provides relevant communications, tools, training, and peer learning to build the capacity of each organization and the network as a whole.

Advance equitable policies and ensure accountability through 2025 and beyond

As we collectively aim to accelerate progress toward our 2025 water quality (TMDL) goals, our Coalition is growing the political and public will to ensure clean water is a consistent priority with broad, bipartisan support well beyond 2025. We advocate for policy that restores and protects our water and supports our most vulnerable communities.

What we mean by:

- **Diversity:** Includes all the ways in which people differ. We embrace a broader definition that includes age, national origin, religion, disability, sexual orientation, socioeconomic status, etc.
- **Equity:** Promoting justice, impartiality, and fairness within the procedures, processes, and distribution of resources by institutions or systems.
- **Inclusion:** Refers to the degree to which diverse individuals are enabled to participate fully in the decision-making processes within an organization or group.
- **Environmental Justice:** The quality of being just, impartial, or fair.
- **Local:** Community-level and community-specific issues, policies, or elected officials.
- **Power-building:** Providing the tools, training, and resources our members need to successfully advocate for and accomplish their goals.

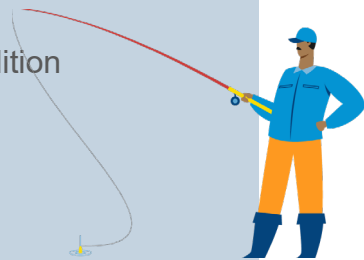
All communities benefit from clean rivers and streams across the Chesapeake watershed

HOW WE WILL MEASURE SUCCESS

- Coalition Steering Committee reflects demographics of our population within the Watershed
- 15% increase in Coalition membership overall with an emphasis on representation from diverse communities
- Secure new funding to work with and support Indigenous People and Native American Tribes
- 70% of Young Professionals of Color participants stay in the environmental sector
- 40% of Coalition members have fully developed DEIJ implementation plans
- Grow Coalition's full-time staff from four to five by 2025

- Achieve federal policy and funding objectives
- Achieve state policy and funding objectives set by state leads
- Widespread bipartisan support among watershed delegation members for Chesapeake-specific programs and funding
- EPA Chesapeake Bay Program funded at full authorization level or higher
- Chesapeake WILD grant program funded at full authorization of \$15 million

- Next Bay Agreement is co-created through an inclusive process
- Coalition members receive a high and growing level of satisfaction and value from being part of the Coalition
- 80% of members engaged (participate in Lobby Day, participate in work group, attend conference, etc.)
- 65% of members sign on to appropriations requests
- 50% increase in funding for state leads by 2025





It's All Connected

WATER

Stormwater. Drinking water. Water that flows through our rivers and streams. They are all connected. Water flows through multiple issues, including public health, land conservation, energy, and the regional economy.

EQUITY

Tree Equity. Redlining. Public Health. Disproportionate Impacts. Systemic racism and other historic inequities are embedded in our water policies and infrastructure. What harms one of us, hurts all of us.



CLIMATE

Warming temperatures. Rising seas. Flooding. Hurricanes. The list of climate impacts is long. “Frontline” communities with the fewest resources to confront these devastating impacts are often the first affected and hardest hit, and would benefit from climate preparedness and green infrastructure.

JUSTICE

Access. Policy change. A just society cannot exist without environmental justice. Our work is rooted in a set of decisions, policies, systems, and structures that benefit some and harm marginalized communities.

- 80% of members engaged (participate in Lobby Day, join work group, attend conference, etc.)
- 70% of YPC participants stay in the environmental sector
- Widespread bipartisan support among watershed delegation members for Chesapeake-specific programs and funding
- EPA Chesapeake Bay Program funded at full authorization level or higher
- Chesapeake WILD grant program funded at full authorization of \$15 million
